Park City Calms Fears, Ready to Serve

Credit Union Commits to Help Those Impacted by COVID-19

MERRILL, WISC. – While there are a lot of concerns over the COVID-19 Coronavirus, Park City Credit Union is not only doing its part to stop the spread of the pandemic but relieve the fears that come with it.

"COVID-19 is impacting individuals, families and small businesses," said Park City CEO Val Mindak. "We understand that many are facing financial hardships and may not know where to turn. I want people to know they can turn to Park City Credit Union."

For current members who are struggling to make payments, the credit union is offering payment deferral options. Likewise, those with Christmas Club or Savers Sweepstakes accounts the credit union is waiving early withdrawal fees. Qualified individuals that are experiencing cash-flow challenges should reach out to Park City to discuss low-rate, Relief Loan options.

The credit union also offers free financial counseling through its partnership with GreenPathTM Financial Wellness. This free service can help with budgeting, housing, student loan debt, credit report coaching, debt management, and how to avoid bankruptcy, foreclosure and repossession.

"We want to bring peace-of-mind to those impacted by COVID-19 and that only comes with real, meaningful solutions," Mindak said. "If you are someone concerned about your financial health in this unprecedented time, please know we are here for you."

The credit union also wants people to know that the safest place for one's money is inside a credit union. Credit union deposits are insured by the National Credit Union Association, and any deposit with Park City will continue to be protected up to at least \$250,000.

For the safety and health of its members and employees, all Park City locations have transitioned to drive-thru only. In doing so, the Dave's County Market Office has temporarily closed, as it has no drive-thru. With the temporary suspension of the Dave's County Market operations, Park City temporarily reopened its Merill West Drive Up to serve those who typically use Dave's County Market on the west end of Merrill.
